  - Funds Raised Update: Total donations received \$224,544.19, total pledges \$33,123, fundraiser total was \$18,692.43 for a grand total of \$276,359.62. Total expenses including the additional repairs are \$307,060. Amount remaining is \$30,700.38.
  - Pledge Reminder Mailing it was discussed to send a letter to all parishioners with a funds raised update and also to thank them for their donations and include an insert stating the amount remaining of unpaid pledges to those applicable parishioners. Father will draw up a letter and send it out via email to the group to review. Would also like to get a current photo of the church and have it printed on a postcard to include with the letter.
  - Payment Status father submitted a request to the Arch Diocese requesting our funds a few weeks ago. The funds have not been received yet. He will give them a call tomorrow to check the status.
     Krause has not received any payment to date.
- b) Visitation Shared Expenses Responsibilities Discussion Shared expenses are divided 35% paid by Visitation and 65% paid by Sacred Heart. This change was made retroactive to July 1, the new fiscal year. Father's housing rent and Sacred Heart Parish office rent have been added to the list of shared expenses with Visitation parish pays towards. These added expenses are broke out in separate accounts on the shared expense spreadsheet.
