- **4. Minutes:** Minutes from the November 12, 2015 meeting were reviewed. It was moved by Jim and seconded by Don to approve the above mentioned minutes with. Motion carried.
- **5. Financial Reports:** Financial Reports were all reviewed. There is \$1,600 in the Access to the Future November Income Statement that needs to be moved to the Roofing Project account as this was donations Phil had received prior to the fundraiser mailing. If expenses are based on parishioner size this does not change cluster board representation. Cluster Board representation is four per parish per constitution.
